

Consent for data processing

By submitting personal data in the fields provided on the official website of the Republican Unitary Enterprise “National Airport Minsk” (hereinafter – the Operator) at <https://airport.by/kontakty/Feedback> (hereinafter – the Website) and by ticking the box labeled “I agree to the processing of personal data” individual/subject of personal data (hereinafter – the User) gives their consent to the Operator (Operator’s address: 220054, the Republic of Belarus, Minsk, territory of the National Airport Minsk) to process the provided personal data such as:

personal name (optional), phone number (optional), category (passenger/visitor of the airport (optional): date (optional), flight number (optional), other information, specified in the field labeled “Message” and in the photo/video attachment area (optional) in accordance with Article 5 of the Law of the Republic of Belarus dated 07.05.2021 No. 99-3 “On the protection of personal data”.

Processing of the User’s personal data is performed for the purposes of: entering the personal data filled in by the User in the fields provided on the Website into automated information system, databases, the Operator’s lists of the messages received;

reviewing of the message, received by the Operator by filling in the required data in the fields provided on the Website;

informing the User on the results of the consideration of the message received.

Processing of the personal data is performed using automatic means by entering the User’s personal data into the Operator’s information systems, databases, lists and is expressed in the following actions with the personal data: collection, systematization, storage, modification, usage, blocking, provision, deletion of personal data. Operator does not process cross-border transfer of the personal data and does not entrust the processing of the personal data to the Third Parties.

The User confirms the correctness of the provided data and agrees that they bare the risk of any negative consequences in case of specifying unreliable (inaccurate) data. The User is informed that they at any moment, having addressed the Operator in writing by sending an application (to the postal address of the Operator – 220054, the Republic of Belarus, Minsk, the territory of the National Airport Minsk), containing their personal signature, has the right:

to obtain the information related to the processing of the personal data by the Operator and changes to the personal data;

to request the Operator to amend their personal data subject to the personal data is incomplete, outdated or inaccurate;

to receive the information from the Operator on the provision of their personal data to the Third Parties once a year on the free-of-charge basis;

to request from the Operator free-of-charge termination of the processing of their personal data, including its deletion subject to the absence of grounds for processing of the personal data provided for by the legislation of the Republic of Belarus.

The User is informed on the right to withdraw their consent for data processing by:

applying to the Operator by submitting an electronic application in pdf., jpg., jpeg. formats, containing their personal signature, to the Operator's email address: info@airport.by.

applying to the Operator by submitting a hard application containing their personal signature to the postal address of the Operator (220054, the Republic of Belarus, Minsk, the territory of the National Airport Minsk”).

Shall the field labeled “I agree to the processing of personal data” left blank, the Operator is not able to view/consider the message as it is not sent.

The present Consent is valid for 1 (one) year from the date of its receipt.
